

MercyOne Genesis DeWitt Medical Center completed a comprehensive Community Health Needs Assessment (CHNA) adopted by the Board of Directors on November 7, 2024. MercyOne Genesis DeWitt performed the CHNA in adherence with applicable federal requirements for not-for-profit hospitals set forth in the Affordable Care Act (ACA) and by the Internal Revenue Service (IRS). The assessment considered a comprehensive review of secondary data analysis of patient outcomes, community health status, and social influencers of health, as well as primary data collection, including input from representatives of the community, community members and various community organizations. Genesis Health System changed its name to MercyOne Genesis on October 1, 2024.

## **Our Hospitals**

MercyOne is a connected system of health care facilities and services dedicated to helping people and communities live their best lives. The system's more than 220 clinics, medical centers, hospitals and care locations are located throughout the state of Iowa and beyond. MercyOne employs more than 22,000 colleagues.

MercyOne Genesis, its affiliates and partners, offer a continuum of health care services for a 17-county region of Eastern Iowa and Western Illinois. MercyOne Genesis is one of the largest employers in the Quad Cities, with more than 5,000 employees.

MercyOne Genesis DeWitt Medical Center, part of MercyOne Genesis, is a 13-bed critical access hospital with cardiac and pulmonary rehabilitation, breast health, emergency services, gastroenterology, post-acute stroke, infusion, occupational therapy, ophthalmology, pain management, physical rehabilitation, radiology/imaging, respiratory care, sleep disorders, and speech/language pathology.

## **Our Community**

The MercyOne Genesis DeWitt service area includes the City of DeWitt and the surrounding rural areas. The nearest cities are Clinton, IA to the east and the Quad Cities to the south. With a population of 7,630, DeWitt is considered a small, rural community. The greater Clinton County region has a median age of 42.5, which is higher than median lowa and U.S. age of 38. The population is mostly Caucasian, with 92.3% White, 2.6% Black, 0.05% Native American, 0.6% Asian, and 4.3% Hispanic.

MercyOne Genesis DeWitt is currently the only hospital in the community, with additional MercyOne Genesis services at Scott Drug and family medicine clinics.







## Our Approach to Health Equity

While community health needs assessments (CHNA) and Implementation Strategies are required by the Internal Revenue Service (IRS), Trinity Health ministries have historically conducted CHNAs and developed Implementation Strategies as a way to meaningfully engage our communities and plan our Community Health & Well-Being work. Community Health & Well-Being promotes optimal health for people experiencing poverty or other vulnerabilities in the communities we serve by addressing patient social needs and investing in our communities through dismantling oppressive systems, including racism, and building community capacity. Trinity Health has adopted the Robert Wood Johnson Foundation's definition of Health Equity - "Health equity means that everyone has a fair and just opportunity to be as healthy as possible. This requires removing obstacles to health such as poverty, discrimination, and their consequences, including powerlessness and lack of access to good jobs with fair pay, quality education and housing, safe environments, and health care." MercyOne is a member of Trinity Health, based in Livonia, Michigan, one of the largest not-for-profit Catholic health systems in the country.

This implementation strategy was developed in partnership with community and will focus on specific populations and geographies most impacted by the needs being addressed. Racial equity principles were used throughout the development of this plan and will continue to be used during the implementation. The strategies implemented will mostly focus on policy, systems and environmental change as these changes are needed to dismantle racism and promote health and well-being for all members of the communities we serve.

## Health and Social Needs of the Community

MercyOne Clinton Medical Center and MercyOne DeWitt Medical Center conducted a joint CHNA in 2023 and early 2024. The CHNA identified the significant needs for health and social drivers of health within the DeWitt community. Community stakeholders then prioritized those needs during a facilitated review and analysis of the CHNA findings. The significant health needs identified, in order of priority include:

# 1. Mental Health DeWitt has 88% fewer mental health providers than the national average (84% fewer than the Iowa average) In the community survey, 45% and 62% of respondents said mental health is a concern for adults children respectively In the community survey, 46% faced challenges in receiving mental health care, mostly for cost and appointment availability Suicide rate is 40% higher than the national rate (25% higher than the lowa rate). ## Hospital Implementation Strategy

#### Significant health and social needs to be addressed

MercyOne Genesis DeWitt, in collaboration with community partners, will focus on developing and/or supporting initiatives and measure their effectiveness to improve the following needs:

Mental Health - CHNA pages 21-22. A second community survey of DeWitt and the surrounding rural area identified mental health as the greatest need in the community. An advisory committee of community members supported the decisions to focus on mental health.

#### Significant health and social needs that will not be addressed

MercyOne Genesis DeWitt acknowledges the wide range of priority health and social issues that emerged from the CHNA process and determined that it could effectively focus on only those needs which are the most pressing, under- addressed and within its ability to influence. MercyOne Genesis DeWitt does not intend to address the following needs in this implementation strategy:

- Substance Abuse While MercyOne Genesis DeWitt will not address this need in the implementation strategy, we will continue to address this need within our emergency department and programs within MercyOne Davenport Medical Center. Furthermore, much of the identifying data and community needs originates from Clinton, IA rather than DeWitt, IA.
- Access to Care While MercyOne Genesis DeWitt will not address this need in the implementation strategy, we will continue to address this need through our hospital and family medicine clinics in DeWitt, as well as the several programs identified in MercyOne Davenport Medical Center's and MercyOne Silvis Medical Center's CHNA and implementation strategy.
- Cancer While MercyOne Genesis DeWitt will not address this need in the implementation strategy, we will continue to address this need through our system through screening programs at other sites and providing care through our emergency department.
- Access to Childcare Due to MercyOne Genesis DeWitt's focus on health care and related needs, we will not address this need in the implementation strategy. Furthermore, a secondary community survey for DeWitt did not identify childcare as a top need.
- Food Insecurity MercyOne Genesis Davenport through the MercyOne Genesis FoodPlex, which is an initiative in the MercyOne Genesis Davenport and Silvis 2022 implementation strategy.

- Housing & Homelessness Due to MercyOne Genesis DeWitt's focus on health care and related needs, we will not address this need in the implementation strategy. However, we will continue to provide support and direction through our emergency department.
- Obesity, Obesity-Associated Disease, Exercise While MercyOne Genesis DeWitt will not address this need in the implementation strategy, we will continue to address this need at other facilities, such as MercyOne Genesis Davenport through the MercyOne Genesis FoodPlex and Diabetes Care Management programs, which are initiatives in the MercyOne Genesis Davenport and Silvis 2022 implementation strategy.
- Access to Dental Care Due to MercyOne Genesis DeWitt's focus on health care and related needs, we will not address this need in the implementation strategy. Furthermore, a secondary community survey for DeWitt did not identify childcare as a top need. Much of the data supporting this need originated in Clinton, IA.
- Asthma While MercyOne Genesis DeWitt will not address this need in the implementation strategy, we will continue to address this need at other facilities with screening programs as well as through our emergency department. Furthermore, a secondary community survey for DeWitt did not identify childcare as a top need.
- Teen Pregnancy While MercyOne Genesis DeWitt will not address this need in the implementation strategy, we will continue to address this need in our emergency department and family medicine clinics as well as the Visiting Nurse Association in DeWitt and the Quad Cities.

This implementation strategy specifies community health needs that the hospital, in collaboration with community partners, has determined to address. The hospital reserves the right to amend this implementation strategy if circumstances warrant. For example, certain needs may become more pronounced and require enhancements to the described strategic initiatives. During these three years, other organizations in the community may decide to address certain needs, indicating that the hospital should refocus its limited resources to best serve the community.
