## MercyOne welcomes the Tanzanian Miracle Kids back to Siouxland

MercyOne Siouxland Medical Center along with Siouxland Tanzania Educational Medical Ministries (STEMM) and Western Iowa Tech Community College welcomed back the three Tanzanian Miracle Kids to Siouxland with a ceremony at MercyOne.

Five years ago, Siouxland opened its arms to three African children from Tanzania. A school bus carrying 13-year-old Sadhia, 13-year-old Doreen and 12-year-old Wilson crashed, killing 35 people. The three children survived due to the heroic efforts of STEMM and were

transported to MercyOne Siouxland Medical Center, then known as Mercy Medical Center, for life-saving care. Sadhia, Doreen and Wilson had over 20 broken bones and Doreen was paralyzed when she arrived. But due to the care she received, she is able to walk again.

Today, their journey in Siouxland continues at Western Iowa Tech Community College. In October 2021 they graduated high school and decided to continue their educational journeys in the city that saved their lives.

"It's wonderful to see Sadhia, Doreen and Wilson doing so well," said Lea Greathouse, MercyOne Western Iowa vice president of Mission, marketing and support services. "Five years ago MercyOne was blessed to be part of their survival story, and it is so good to see

## **Physician Assistant Supervision**

As of January 1, 2018, the Iowa Board of Medicine requires a written supervisory agreement to be in place with each PA you supervise.

The agreement must be established prior to supervision. Essential elements of this agreement should define supervisory relationship and expectations, and must consider PAs demonstrated skills, training and experience and scope of medical practice. Each supervising physician and physician assistant shall communicate about and consult on patient complaints, medical problems, complications, emergencies and patient referrals. The physician must be available for timely consults either in person, by telephone or other electronic means.

A provision in the agreement should also set forth a plan

for completing and documenting chart reviews. The review should encompass the scope of the PA's practice and the review should be discussed with the PA. Copies of the agreement should be maintained on file and should not be sent to the lowa Board of Medicine unless requested by it.

The physician delegates medical services to be performed by the PA and you cannot supervise more than five PAs at a time.

A physician who supervises a PA shall notify the lowa Board of Medicine of the supervisory relationship within 60 days of the provision of initial supervision and at the time of your license renewal.


