About the Hospital

MercyOne Centerville Medical Center is a part of the MercyOne Health System, a joint operating agreement between Common Spirit Health and Trinity Health in Iowa. Through this association, MercyOne Centerville Medical Center belongs to one of the largest Catholic healthcare systems in the country.

Located in Centerville, Iowa, MercyOne Centerville Medical Center is a not-for-profit, Catholic critical access hospital serving the Appanoose County area for 112 years. The hospital is dedicated to the mission and vision of MercyOne: Serving with fidelity to the Gospel as a compassionate, healing ministry of Jesus Christ to transform the health of our communities while setting the standard for a personalized and radically convenient system of health care services. The hospital provides comprehensive inpatient and outpatient services as well as specialist physician clinics. The hospital also operates a nursing home unit, geriatric mental health service and medical clinic with primary care physicians and advanced registered nurse practitioners including Quick Care open seven days a week. Our Mission

The hospital's dedication to assessing significant community health needs and helping to address them in conjunction with the community is in keeping with its mission. As MercyOne Centerville Medical Center, we make the healing presence of God known in our world by improving the health of the people we serve, especially those who are vulnerable, while we advance social justice for all.

Financial Assistance for Medically Necessary Care

It is the policy of MercyOne to provide, without discrimination, emergency medical care and medically necessary care in MercyOne hospital facilities to all patients, without regard to a patient's financial ability to pay. This hospital has a financial assistance policy that describes the assistance provided to patients for whom it would be a financial hardship to fully pay the expected out-of-pocket expenses for such care, and who meet the eligibility criteria for such assistance. Description of the Community Served

The hospital serves Appanoose County Iowa, a rural county located in south central Iowa bordering Missouri. A summary description of the community is below, and additional details can be found in the CHNA report online at

https://www.mercyone.org/centerville/. In 2021 Robert Wood

Johnson Health Rankings, Appanoose County ranked 98 out of 99 counties in Iowa. The county has a high level of poverty compared to the rural norm, where social determinants have a direct impact on healthcare needs.



• Appanoose County is predominately a rural community located in south central Iowa on the border of Missouri. It is located 90 minutes from Des Moines and 3 hours from Kansas City. With its lack of



proximity to an urban area, Centerville is considered a regional retail center, despite the socioeconomic issues that impact the area. Although it is in an agricultural area, the community is not solely dependent on the agricultural economy and houses an industrial area that accounts for approximately 2000 jobs.

- The population of Appanoose County is 12,426 (based on 2019 data). 22.9% of the population is over 65 years old with 5.6% under the age of 5. Children in single parent households make up a total of 20.7% compared to the rural norm of 18.3%.
- Appanoose County is in an economically stressed area and is overall ranked the 2nd <u>least healthy</u> <u>county in Iowa</u> (2021 Robert Wood Johnson County Health Rankings). The county ranked 98th in Health Outcomes, 96th in Health Factors and 75% in Physical Environmental Quality out of 99 counties in Iowa.
- The average per capita income (\$26,012) is significantly lower than the state's average. 22.9% of the population is over age 65. The number of individuals in poverty is 15.8%, as compared to the state average of 11.9%, and the number of children in poverty is 24%. 61.8% of children in Appanoose County are eligible for free or reduced lunch. Those with food insecurity is 12.5%, and those with limited access to healthy foods (store) is 5.1%. The severe housing problem was recorded at 13.7% compared to the rural norm of 11.7%
- In Appanoose County, 19.2% of the Medicare population has depression and the age adjusted suicide mortality rate per 100k is 14.1. The age adjusted poor mental health days is 4.0 compared to the rural norm of 3.8.
- Appanoose County has an obesity percentage of 44.6% and 33.9% report physical inactivity. 21.3% smoke while the excessive drinking percentage is 23%. Medicare hypertension percentage is 60.3% while heart failure is 16.9%. Chronic kidney disease amongst the Medicare population is 24.3% compared to the rural norm of 20.8%.

Community Assessment and Significant Needs

The health issues that form the basis of the hospital's community health implementation strategy and programs were identified in the most recent CHNA report, which was adopted in June 2022. The CHNA contains several key elements, including:

Significant Needs Not in Hospital's Primary Scope

*The needs in the table above noted with an asterisk are not in the hospital's primary scope of capacity and services, but the hospital will collaborate in some form with other key leaders in the community to address those needs.

Substance Abuse: The hospital does not have the resources or professional expertise to directly address this need. However, MercyOne will become an active participant in collaboration efforts with the community and local substance abuse services and resources agencies to partner on initiatives where the hospital can provide support. Those initiatives have been listed in this plan.

Poverty: MercyOne Centerville Medical Center does not plan to directly address this particular need because other service agencies are addressing this need directly and developing action plans. However, the hospital will continue initiatives that provide support to those living in poverty. Those initiatives have been listed in this plan.

Women's Health: The hospital no longer provides Obstetrics service nor will be seeking to reinstate that service. The hospital and its clinic also do not provide family planning services due to the Ethical and Religious Directives of the Catholic Church for Healthcare. However, MercyOne will collaborate with existing providers to investigate opportunities where services can be accessed locally and to communicate

understanding of where those services are available in the community. Those initiatives have been listed in this plan.

2022 Implementation Strategy

This section presents strategies and program activities the hospital intends to deliver, fund, or collaborate with others on to address significant community health needs over the next three years, including resources for and anticipated impacts of these activities.

Planned activities are consistent with current significant needs and the hospital's mission and capabilities. The hospital may amend the plan as circumstances warrant, such as changes in community needs or resources to address them.

Creating the Implementation Strategy

The hospital is dedicated to improving community health and delivering community benefit with the engagement of its management team, board, clinicians, and staff, and in collaboration with community partners.

Hospital and health system participants included Administrators, Emergency staff, Medical Surgical staff, Health Promotion & Wellness, Nurse Practitioners, Physicians, Hospitalists, Community Relations, and Hospital Board Members.



Community input or contributions to this implementation strategy included participation by 222 individuals on the community survey of needs, including representatives from: Mental Health, Emergency Medicine, Public Health Department, Case Managers, Senior Care, Consumer Advocates, Housing, Insurance, Law Enforcement, Pharmacy, Clinics, Elected Officials, Parents/Caregivers, Media, Clergy, Education, Business/Merchants, and Community Members/Volunteer Leaders. The survey was followed by 35 participants representing the same populations at a town hall meeting and a final implementation planning meeting.

The programs and initiatives described here were selected based on identified community need and ability to have an impact. The top 10 needs were identified from the Town Hall meeting after a comprehensive presentation of primary and secondary research. Participants at an Implementation Planning meeting evaluated the top 10 to determine those areas the hospital can directly impact or those areas where the hospital collaborate with other agencies to assist in impacting or improving
