Urgent Care Partnership – Premier Health and MercyOne

We are excited to share MercyOne has reached final approval for a partnership between MercyOne and

Premier Health for urgent care services. MercyOne urgent care locations in MercyOne's Central Iowa, North Iowa, Western Iowa and Eastern Iowa regions are included, and over the past two weeks we have been working closely with current urgent care team members to share details and coordinate meetings with human resources to address their questions. Integration teams from both MercyOne and Premier Health are working together on the transition, which is expected to be complete this fall.

With MercyOne's recent announcement that Trinity Health will be our sole parent, along with Trinity Health's majority ownership stake in Premier Health, the partnership between MercyOne and Premier Health is a strategic move to guide growth and improve access to care in MercyOne regions.

Existing and future clinics included in the partnership agreement will remain branded MercyOne, with Premier Health managing day-to-day operations.

Legislative Session 2022 Scorecard

The lowa Legislature adjourned in May, and MercyOne is pleased to share its legislative scorecard. It was a challenging session as it relates to controversial topics as a result of COVID-19, but MercyOne used this opportunity to educate the Legislature on our role as a continued extension of the public health system, the importance of being able to manage our operations, especially clinical, and moreover, the ongoing challenges we continue to experience related to workforce and financial pressures related to labor and supply costs. Some of the issues below will carry over, as we know we have more work to do on medical malpractice, certificate of need and Medicaid improvements.

Health Care Workforce		In addition to sweeping income tax cuts and relief for retirement accounts that passed earlier this session, the governor's workforce bill (SF 2383), which had a division dedicated to health care, passed in April. The bill included expansion of the Rural Primary Care Loan Repayment Program, the Health Care Professional Recruitment Program, and the Health Care Loan Repayment Program.	Continue to work with the Legislature and Executive Branch to advocate for additional funds and regulatory relief to make employment and retention in the health care industry easier.
Medical Malpractice		MercyOne continued to work with Iowa Medical Society (IMS) and the larger coalition to secure the votes in the House for a cap on noneconomic damages in medical malpractice cases. With support from the health care industry, the governor's office also made tort reform part of her overall legislative agenda, specifically regarding workforce.	Depending on the outcome of this year's election cycle, the coalition may be at the ready to work through the hard cap discussion again next session.
Temp Staffing Regulation		The lobby team worked to support the lowa Health Care Association in efforts to regulate temp staffing agencies in the state. HF 2521, which establishes heighted requirements on these agencies with the Department of Inspections and Appeals and disallows use of non-compete agreements and liquidated damage clauses in their employment contracts, was signed by Governor Reynolds on May 17. Language for retroactive applicability to all contracts signed on or after January 1, 2019, was also included in the final standings package, HF 2589.	Monitor rulemaking through American Association for Respiratory Care (ARRC) and any possible opposition from staffing agencies during next session.

Pride is also a celebration of change. There have been some major shifts toward LGBTQ+ equality in the past 20 years: we've seen the repeal of the **Defense of Marriage Act** and **Don't Ask Don't Tell**, and the Supreme Court ruling in the Obergefell v. Hodges case that afforded same sex couples the right to marry.

The reason so many of these accomplishments are celebrated now is this: just 50ish years ago, being LGBTQ+ was not only illegal, but the American Psychiatric Association (APA) considered same sex attraction a mental illness.

A brave speech by Dr. John Fryer at the 1972 National Psychiatric Association's national convention helped lay the groundwork for a change in thinking, not just for the APA, but for lawmakers and the courts as well.

Personalized care is provided with a more in-depth understanding of veterans' often complex needs.



This is what Personalize Care looks like to me ...

I received a phone call this morning from a woman in Waterloo who wanted to share how **Lexi**, MercyOne AmeriCorps Community Health Worker (CHW) at MercyOne Bluebell Road Family Medicine, created a positive consumer experience for her and her family member.

The woman is the primary caregiver for a family member with a neurological disorder. She can't lift much weight herself and relies on a transport chair when transporting her family member to medical appointments. Unfortunately, the chair had recently broken. She has utilized MercyOne Waterloo Home Medical Equipment in the past and always has a very positive experience. She reached out regarding a transport chair. Unfortunately she cannot afford a new chair, and the options available through medical equipment were too wide and heavy for her. The medical equipment team connected her with Lexi to explore what resources might be available.

Lexi provided her with the Salvation Army Free Clinic (SAFC) as a resource since they often have

donated medical equipment available. The patient called SAFC, but they were closed for the week. The transport chair was needed urgently for an upcoming appointment so Lexi offered to reach out to a contact at SAFC on her behalf. SAFC shared that they did have a transport chair available. The clinic was closed through the week but Lexi was able to arrange to pick up the chair the next day. She delivered the transport chair to a MercyOne location close to the patient's home, and the patient was able to pick it up the following day.

The woman reached out to Lexi on a Wednesday and picked up her transport chair on Friday. She also shared that Lexi connected her with an additional resource, Love Inc. She is going to connect with them to participate in a group for caregivers.

The woman shared that she immediately felt relieved as soon as she spoke with Lexi. That Lexi was so gracious and kind and was going to help her through this. She shared that MercyOne is more than number one to her.

Thank you Lexi for exemplifying our cultural beliefs each and every day.

This is what Personalize Care looks like to me ...

Electrophysiologists at MercyOne Iowa Heart Center performed their 500th WATCHMAN Left Atrial Appendage Closure Implant procedure at the end of April. This implant is a treatment for patients who have non-valvular atrial fibrillation.

Atrial fibrillation (A-Fib) is a heart condition where the upper chambers of the heart (atrium) beat too fast and with irregular rhythm (fibrillation). Twenty percent of all strokes occur in patients with A-Fib, and A-Fib-related strokes are more frequently fatal and disabling.

"It is an incredible accomplishment for our team to reach this milestone," said **Troy Hounshell, DO**, MercyOne Iowa Heart Center electrophysiologist and medical director of research. "Our team has worked diligently to become leaders in this life-saving technology, implementing both the WATCHMAN and WATCHMAN FLX devices and being part of early research trials bringing them market."

For patients with A-Fib who are at risk for stroke but are unsuitable for blood thinners, the WATCHMAN implant is an alternative to reduce their risk of AF-related stroke. It closes off the LAA to keep harmful blood clots from forming in it and potentially causing a stroke. By closing off the LAA, the risk of stroke is reduced and, over time, patients stop taking blood-thinning medication.

"We are the top implanter in the state and are a leader regionally and nationally for our quality outcomes," said Dr. Hounshell. "We continue to pioneer this therapy to eliminate the need for lifelong blood thinners for our patients."



Team Engagement

MercyOne's Team Engagement is measured by an Annual Engagement Survey. This includes engagement for MercyOne colleagues and physicians. Last year, MercyOne did not conduct the Annual Engagement Survey due to the COVID-19 pandemic. The fiscal year 2021 survey was conducted in April/May 2021 for all colleagues and physicians/providers. The physicians/providers survey was divided into two distinct groups: hospital-based physicians and clinic-based physicians. Overall, MercyOne's Colleague Engagement totaled the 38th percentile compared to the 23rd percentile in fiscal year 2019.
