# **Health Advocacy Update**

## Health care leaders meet with newly elected Congressman Zach Nunn

Health care representatives, including MercyOne leaders, physical therapists, pharmacists, optometrists, nursing facilities and members of AARP, attended a roundtable hosted by U.S. Rep. Zach Nunn. He used the opportunity to gather information for his legislative priorities.

Attendees discussed the current financial environment, the 340B drug pricing program, hospital and rural health clinic payments, workforce issues, continuing waivers after the public health emergency ends and telehealth payment parity.



## Iowa legislature

The lowa Legislature continues to work on health care related bills, and we are pleased that two of our priorities have been accomplished: medical malpractice and the Rural Emergency Hospital (REH) designation. Following is a list of bills that affect MercyOne:

- Medical Malpractice: The new law limits the amount of noneconomic damages that a jury can award a plaintiff against a physician if there is substantial or permanent loss or impairment of a bodily function, substantial disfigurement, or death to \$1 million. This bill was signed by the Governor on February 17.
- Rural Emergency Hospitals: Amends lowa Code chapter 135B to allow for rural emergency hospital licensure. Provides definitions, eligibility requirements, licensure and application requirements, including clarification that a hospital converting to a REH does not require a certificate of need. The bill applies to a general hospital that meets the eligibility requirements located in a county with a population between thirty thousand and thirty-five thousand as of the 2020 census that was operating under a valid certificate of need on and prior to September 1, 2022. The Governor signed this bill in early April.
- Nurse Preceptor Tax Credit: Creates a nurse preceptor tax credit of \$1,000 per tax year against the individual income tax. Defines "nurse preceptor" as a licensed nurse under lowa Code chapter 152 or 152E who supervises nursing students during clinical rotations. Credit is nonrefundable but may be carried forward for up to fixe tax years. Applies to tax years beginning on or after January 1, 2024.

- **340B:** Ensures the integrity of 340B program within the state. Prohibits plans, carriers, TPAs and PBMs from providing discriminatory reimbursement amounts for prescriptions or dispensing fees on the basis of a covered entity's or a contract pharmacy's status a covered entity or contract pharmacy.
- Postpartum Medicaid Extension: Directs the
  department to submit a State Plan Amendment to
  provide 12 months of continuous postpartum coverage
  under the Medicaid program. Appropriates \$5.6
  million for FY 23-24 and \$8.9 million for FY 24-25.
- Governor's Health Care Proposal: In addition to appropriations for the MOMs program, the Governor's health care proposal includes increased funding for the Centers of Excellence grant and creates a statefunded family medicine OB fellowship program.
- Lay Midwife Licensure: Creates a board and license for lay midwives. The bill would require insurance coverage for lay midwife services, allow for administration of medications, etc., but would also limit the liability of health care providers that accept transfers from midwives.
- Physician Assistant Supervision: Would allow physician assistants to practice without the supervision of a physician.



# Health Advocacy Update continued

## State of Iowa support

Governor Reynolds has expanded her investment in health care apprenticeships. The Iowa Health Careers Registered Apprenticeship Program is a grant opportunity aimed at addressing the workforce needs of the health care sector. Program funding helps jumpstart a high school-based registered apprenticeship program (new or existing) that accelerates the pathway into the health field. MercyOne has not yet applied due to regulatory and requirement barriers across the health care and education landscape, but will be meeting with the State, Board of Nursing and Iowa Workforce Development to ensure these aspects are better aligned moving forward.

## **April is Arab American Heritage Month**

In honor of Arab American Heritage Month, Trinity Health and MercyOne are recognizing and celebrating the vibrant and diverse cultures and contributions of the diverse populations of Arab Americans. We especially acknowledge our colleagues and members who are of Arab American descent as they celebrate this national observance.

#### ARAB AMERICANS, CHRISTIANITY AND ISLAM

According to our <u>source</u>, although the Middle East itself is almost entirely comprised of Muslims, Middle Eastern Americans are predominantly Christian. It is a common perception that most Middle Eastern Americans are Muslim. However, only about 25–30% of the Arab American population practices Islam. Furthermore, <u>America by the Numbers</u> indicates that most Arab Americans are Christian – 63% – compared to 24% Muslim and 13% of other or no religious affiliation.



#### MISCONCEPTIONS AND STEREOTYPES ABOUT ISLAM

**Perception:** "Arab" and "Muslim" refer to the same people

Arabs are people who speak Arabic as a native language and identify themselves as Arabs; Muslims are those who practice the religion of Islam.

Many Arabs are not Muslims, and not all Muslims are Arabs. More than a billion people in the world are Muslims, but fewer than 15% of Muslims worldwide are Arabs. Most Muslims live outside of the Middle East, in places like Indonesia, Thailand, Malaysia, India and Pakistan.

The confusion between these terms may stem from the fact that Arabic is the primary language of the Islamic faith, just as Latin was for Catholicism until recently. Therefore, many people expect all Muslims to know at least a few keywords and phrases in the Arabic language.

## Islam's most important holidays

<u>Islam</u> is the second largest religion in the world after Christianity, with about 1.8 billion Muslims worldwide. The word "Islam" means "submission to the will of God." Followers of Islam aim to live a life of complete submission to Allah. Islam teaches that Allah's word was revealed to the prophet Muhammad through the angel Gabriel. Muslims believe several prophets were sent to teach Allah's law. They respect some of the same prophets as **lews** and Christians, including Abraham, Moses, Noah and Jesus. Muslims contend that Muhammad was the final prophet.

Ramadan is a holy month of fasting, introspection and prayer for Muslims. It is celebrated as the month during which Muhammad received the initial revelations of the Quran, the holy book for Muslims. Fasting is one of the five fundamental principles of Islam. Each day during Ramadan, Muslims do not eat or drink from dawn to sunset. They are also

supposed to avoid impure thoughts and bad behavior. Muslims break their daily fasts by sharing meals with family and friends, and the end of Ramadan is celebrated with a three-day festival known as Eid al-Fitr, one of Islam's major holidays. Ramadan always falls on the ninth month of the 12-month Islamic calendar. Ramadan 2023 began on the evening of March 23 and lasts 30 days, ending at sundown on Thursday, April 21.

<u>Eid al-Adha</u>, or the "Feast of Sacrifice," signifies the willingness of the Prophet Ibrahim, known as Abraham in Christianity and <u>Judaism</u>,

to sacrifice his son, Ismail as ordered by Allah. It is one of Islam's most important holidays. Usually lasting three to four days, and celebrated by millions of Muslims worldwide, the holiday begins on the 10th day of the Muslim calendar lunar month of Dhul-Hijja, at the time of Hajj, the annual pilgrimage to Mecca. Considered the holiest of the two Eids, the other being Eid al-Fitr, or "Festival of Breaking the Fast," which commemorates the end of Ramadan, it is one of two major Muslim holidays celebrated across the globe each year.

Genesis made it easy, providing tuition for the four-month program, certification test scholarships, hands-on skills training, hourly compensation, full-time benefit eligibility, and best of all – guaranteed placement at Genesis upon program completion.

# You can report an integrity concern – without retaliation

If you have concerns about an actual or potential integrity issue, you should speak up! Ask questions! Make right decisions!

But if you do speak up, can there be retaliation? What if you are harassed? Could you be punished of intimidated? Will you be fired just for speaking up? Will you get into trouble for reporting something?

No! MercyOne has a strict stance against retaliation, outlined in the Code of Conduct. It states that any action directed against someone for making a good-faith report of a concern will not be tolerated. Further, anyone who does engage in or permits retaliation, intimidation or retribution is subject to discipline, up to and including dismissal. You should report any issues with retaliation right away to your Integrity and Compliance Officer so there can be an investigation.

Retaliation is subject to discipline, up to and including dismissal from employment, suspension of medical staff privileges, or termination of business relationships with MercyOne, in accordance with MercyOne policies and medical staff bylaws, as applicable.
