

MercyOne Siouxland Medical Center CHNA Implementation Strategy Fiscal Years 2019-2021

MercyOne Siouxland Medical Center completed a comprehensive Community Health Needs Assessment (CHNA) that was adopted by the Board of Directors on 5/15/2019. MercyOne Siouxland Medical Center performed the CHNA in adherence with applicable federal requirements for not-for-profit hospitals set forth in the Affordable Care Act (ACA) and by the Internal Revenue Service (IRS). The assessment took into account a comprehensive review of secondary data analysis of patient outcomes, community health status, and social determinants of health, as well as primary data collection including input from representatives of the community, community members, and various community organizations.

Hospital Information

MercyOne Siouxland Medical Center's lives the traditions, vision and values of the Sisters of Mercy. MercyOne Siouxland Medical Center is a regional Level II Trauma Center that meets the needs of residents in Iowa, Nebraska and South Dakota. In addition to the main hospital in Sioux City, MercyOne Siouxland owns rural hospitals in Primghar, Iowa, and Oakland, Nebraska, manages hospitals in Pender, Nebraska and Hawarden, Iowa, and operates a primary care clinic network, specialty care clinics and

home health services. MercyOne Siouxland also partners with other community healthcare providers to sponsor a regional cancer center, paramedic services, hospice services, a freestanding surgery center and a variety of other health services.

Mission

MercyOne Siouxland Medical Center's Mission is to serve with fidelity to the Gospel as a compassionate, healing ministry of Jesus Christ to transform the health of our communities.

Health Needs of the Community

The CHNA conducted throughout 2018 identified the significant health needs within the MercyOne Siouxland Medical Center's community. Those needs were then prioritized based on the results of an activity where community representatives ranked the community needs. The significant health needs identified, in order of priority include:

1) Housing/Homelessness	 To decrease homelessness and improve housing environments within Siouxland
2) Mental Health	 To improve the mental health landscape in the Siouxland area
3) Sexual Health	 To provide accurate sexual health education, services and preventions services in the Siouxland area
4) Substance Abuse/Tobacco	 To decrease use of substance abuse in the Siouxland area
5) Obesity/Chronic Health Condition	 To ensure obesity rates do not continue to climb in the Siouxland area
6) Access to Care	 To improve access to care within Siouxland

Hospital Implementation Strategy

MercyOne Siouxland Medical Center's resources and overall alignment with the hospital's mission, goals and strategic priorities were taken into consideration of the significant health needs identified through the most recent CHNA process.

Significant health needs to be addressed

MercyOne Siouxland Medical Center will focus on developing and/or supporting initiatives and measure their effectiveness, to improve the following health needs:

Brief description of need:

The number of residents in the communities served that reside in a housing unit that has at least one substandard condition is 23%. During a point in time count in 2018, 292 individuals were identified as homeless. During the 2017-2018 school year, the Sioux City Community Schools identified 388 students as homeless.

Goal: Decrease homelessness and improve housing environments within Siouxland.

SMART Objective(s):

Decrease the number of homeless individuals in Sioux City from 298 to 250 by 2021. Assist with community efforts in opening one 24/7 facility by 2021 that expands access to programs/services to reduce homelessness.
